



- 9:00 Keynote: You Get What You Pay For: How Should We Finance Urban Infrastructure Carson Hall, Salon A The poor state of municipal infrastructure in Canada is the subject of frequent news stories. Every day, we read about roads that are congested, transit systems that are in need of major investments, bridges that are crumbling, water treatment plants that need to be replaced, and more. How should cities pay for repairing, replacing, or building new infrastructure? This presentation will look at a number of possible methods, including user fees, property and other taxes, land value capture, development charges, borrowing, and public-private partnerships. The choice of funding mechanism will depend on the characteristics of the infrastructure we need. For example, is the infrastructure growth-related? Can we identify the beneficiaries? Are the assets large in scale? To raise the needed revenues from any of the possible sources will also require building public fiscal trust and convincing taxpayers that you get what you pay for

10:30 Panel | Finance & the Smart City Carson Hall, Salon A

Local governments around the globe are undergoing a digital transformation as data and technology is increasingly used to analyze, monitor and optimize the systems that underpin the environmental, economic and social sustainability of their communities. To support this transformation, the Government of Canada launched the 'Smart Cities Challenge' in 2017, committing in excess of \$75 million dollars of funding to selected community projects that use data and connected technology to improve the lives of their citizens. The Government of British Columbia followed suit in 2018 launching the 'Smart Communities' pilot program providing in excess of \$100 thousand dollars to encourage communities across BC to adopt smart community technologies and innovation. In this session, panelists from the City of Nelson, City of Surrey, and South Island Prosperity Project will each explore the smart cities projects submitted under these funding schemes and how they propose to leverage this funding for their respective communities. 13:30 Disruptive Technologies and the Public Sector's Role Sidney

his session will serve as a survey of how IT, big data, and other technology trends that make up the broader scope of smart cities will change your municipality's risks. We will review what technologies are being implemented, how they impact risk, and the ways the municipalities are reacting to these emerging risk exposures.

13:30 How Analytics Can Reshape the Infrastructure Industry Colwood

Rapid technological advancements are reshaping the infrastructure industry. Application of advanced data analytics can help facilities owners optimize existing assets and make better capital-planning decisions. Let us show you how advanced analytics is creating an ecosystem for better facility management of government buildings, hospitals, roads, and water treatment facilities.

14:15 Cannabis in the Community Colwood

Now a reality, what do Local Governments need to know from Human Resources and Risk Management perspectives? This session will provide insight and recommendations to assist with amending your Human Resources Manual to include dealing with the use of medical and recreational marijuana and workplace safety. Also information on how the Extended Health Care providers are dealing with Medical Marijuana as a prescribed medication. Risk Management of legal grow operations and licenced retailers poses some new challenges.

We will provide information on resources available to municipalities, and discussion around many of factors to be considered in decision making on this emerging topic.

14:15 Smart Cities – Not just for the Large Metropolis Sidney

We have heard a lot about Smart Cities and how it can dramatically help a municipality manage its assets and resources effectively; however, the vast majority of the resources out there is focused on the larger municipality. This session will focus on how rural, smaller and medium sized municipalities can apply the concepts of Smart Cities on a scale relevant to their communities.

14:15 Municipal Price Index (MPI) Overview Carson Hall, Salon A

A five-year financial plan reflects the best information available at the time the financial plan is developed. This session provides a detailed overview of how the City of Abbotsford has been setting its inflationary factor to inform its financial mandate for the last several years, which may inform attendees' future approach to budgeting for inflation. The Municipal Price Index (MPI) is a key component of the financial plan framework introduced in the City of Abbotsford in 2014, and is based on the model used by Statistics Canada to calculate the Consumer Price Index (CPI). Annually, staff have recommended a financial mandate for the five year financial plan that relies on MPI to guide tax rate setting. MPI is a calculation of inflation using a 'basket of goods' purchased by local governments, which differ significantly from those used by consumers; so while the CPI represents the purchasing patterns of the average Canadian consumer, the MPI reflects purchasing patterns by local government. Adoption of a mandate that includes inflation is important to protect local governments' ability to operate existing programs and services; the use of MPI is superior to CPI as a tool to incorporate inflation as it is calculated using a specific local government's budget data, and uses sources both specific to that government and external data sources such as CPI for some 'basket' items. This specificity makes MPI a more transparent and defensible approach.

9:00 Keynote: Building a Culture that Supports Ethics Carson Hall, Salon A

Over the past year, GFOA has sought to reinvent our decades old code of ethics. Instead of a list of do's and don't's, the new code is values based. Chris will present the new code of ethics which is founded on the value of "trustworthiness." It was informed by extensive research into what has been proven to work for encouraging and maintaining ethical behavior. It is also based on an underlying assumption that most GFOA members already know right from wrong – and where GFOA can help most is assisting its members to stand up for their values when they face pressure to the contrary. This presentation will provide you with tools, tips, and techniques you can use to build a culture that is supportive of ethical behavior and living your values.

10:15 Embracing Bots: The Next Wave of Business Transformation Carson Hall, Salon A

For many, Robotic Process Automation (RPA) is an unknown, an opportunity or a threat. Let's work through what RPA is, what it isn't and where this new wave of transformation can help build resiliency in your organization. We'll present examples of how Bots are being used today and how this aligns with the tasks and objectives of the Finance organization.

11:15 Big Data, Smarter Spending: The Coming Revolution in Fiscal Impact Analysis Sidney

Financial executives face the constant challenge of accessing disparate data sources in order to calculate projected

fiscal impacts of decisions, with data sources fragmented across government departments and between jurisdictions. With the emergence of big data and the growing phenomenon of the Internet of Things, there are both opportunities and challenges in integrated unconventional data sources to improve the accuracy, reduce cost and speed deployment of fiscal impact analysis. UrbanLogiq will demonstrate how a common operating platform that breaks down data silos within and between government, and marries public and private sector data powered by machine and deep learning artificial intelligence can power a new wave of innovation in fiscal impact analysis

11:15 Tale of a Tax Sale: From Economic Drain to Economic Driver Carson Hall, Salon A

Opened in 1955, the Skeena Cellulose pulp mill was the source of roughly 20% of the City of Prince Rupert's tax revenues and the City's main employer. In 2001, the mill owners filed for bankruptcy and the site was eventually acquired unwillingly by the City of Prince Rupert at tax sale in 2009. Subsequent to litigation challenging the tax sale, City staff began overseeing the dismantlement of the derelict site in 2015, along with the redevelopment of the island to layout a brighter economic future for the community.

11:15 Local Service Tax Colwood

One of the most important functions of a local government is to provide services to its citizens such as roads, water supply, fire protection and sewage collection and disposal. The Community Charter grants municipalities the power to deliver these services by way of a local area service. The principle behind local area services is that while those services which benefit the municipality as a whole should be paid for by the municipality out of its general revenues, those services which benefit only a minority of property owners should be paid by them. The local area service is paid for by way of a local service tax. This tax can take the form of property value tax, a parcel tax or both. In most cases the responsibility for setting up local area services rests with the Engineering department but the Finance department also has a critical role in determining the type of tax to charge and in administering the tax. As such, it is important the finance officers understand what local area services taxes.

13:45 Panel | Finance Officer Forum: Beyond Super Average: Improving Financial Services Through Strategic Planning Carson Hall, Salon A

Today, more than ever before, the local government Finance Officer faces many challenges as the role itself continues to evolve. Last year's forum theme was 'What Keeps You Up at Night?'. This year the forum will explore the strategic role of the finance officer through the lens of the Finance Strategic Planning Framework Project. The session will open with an overview of the project followed by project proponent presentations and moderated panel discussion with Q&A. Genelle Davidson, Divisional Director Financial Services for the City of Kelowna and Board Member of GFOABC, will lead out the panel presentations. Genelle will be joined by Rick Danyluk, Manager of Financial Planning for the District of North Vancouver and Board Member along with Kathy Humphrey, Director of Corporate Services for the City of Kamloops. This panel session will be highly interactive, delegates will have the opportunity to join the conversation.

15:15 Asset Management: A Focus on the Funding Colwood

You do not have an infrastructure deficit, you have an infrastructure funding deficit. Using the City of Colwood as a recent case study. this session will demonstrate why solving the funding piece of the asset management equation is essential. Local governments do not always have robust asset management software, policies, or detailed capital spending plans to rely on. Indecisiveness can create an escalating and compounding funding deficit. You owe it to your Engineering colleagues to properly fund infrastructure replacement in a fiscally sustainable manner.

CONFERENCE SESSIONS (CONTINUED)

15:15 A Tale of Two Cities: Financing Water and Wastewater Systems Sidney

While financing water systems and setting rates is always tricky, the issues vary from town to town. This presentation will look at how two different BC communities have faced this challenge in recent years and their plans for the future. Powell River is grappling with funding a new wastewater treatment plant and finding the right balance between borrowing, seeking grants and short term rate increases. They must address this in addition to the ever-present challenge of dealing with ageing infrastructure. In recent years, Gibsons has taken a history of system underfunding head-on through a series of fairly steep rate increases. Anbsp; To do this has required extensive communications efforts and improvements to asset management planning. Their experiences will inform a discussion about how water and wastewater rates both drive and set community policy. We will explore themes including revenue sufficiency, revenue stability, affordability, and communications with rate payers and elected officials.

15:15 Moving from Excel to Excellence: Corporate Performance Management (CPM) for Local Government Carson Hall. Salon A

The benefits of financial benchmarking in local government are clear: you can tell at a glance whether your costs of providing services to your community are high, low, or in line with those of your peer group. Such comparative measures are extremely valuable when your organization establishes and defends its spending priorities. Unfortunately, benchmarking is difficult in practice due to a lack of standardization. Even communities that are similar in size, service delivery, and complexity often differ significantly in their approach to organizing financial information. This makes apples-to-apples comparisons so labor intensive and error prone that few communities have the time or resources to do it. In this session, we discuss how a well-designed chart of accounts can facilitate both statutory reporting and emerging modes of decision support, including benchmarking. We also discuss workarounds when redesigning your chart of accounts is not practical.






