

9:15 Courage Inside the Fire: A Story of Leadership Skaha Ballroom

During the catastrophic Alberta wildfires, fire chief Darby Allen shot to global acclaim for guiding the 88,000 residents of Fort McMurray to safety with no loss of life—the largest evacuation in Canadian history. The 2016 Alberta wildfire season was the costliest disaster in Canadian history—destroying 2,400 buildings and homes and displacing the entire community of Fort McMurray. Through it all, from beginning to end, was Fire Chief Darby Allen. A figure of stability to his community, a reliable source of information to the press, and a humble leader, Allen became the human face of both incredible tragedy and courage. Framed as a personal narrative, this keynote provides a look into Darby's day-to-day struggles against the fire, shining a light on the community—and national—trust that empowered his efforts.

10:30 Floods & Fires: Finance at the Front Lines Skaha Ballroom

Set against the backdrop of last year's unprecedented and widespread spring flooding and raging wildfires, which impacted many communities across B.C., this panel will explore the key role that the local government finance office plays in the emergency management process—mitigating, preparing for, responding to and recovering from emergency events. Marilyn Rilkoff from the Regional District of the Central Okanagan presents a compelling and thoughtful narrative on her experience in the RDCO Emergency Operations Centre. Marilyn will be joined by Jackie Dueck from the City of Kelowna, Pete Prendergast from Emergency Management BC and Ron French from the Office of the Fire Commissioner for a roundtable panel discussion on lessons learned from 2017. Delegates will gain firsthand knowledge of the role the finance office plays during emergency situations.

13:00 Auditor General for Local Government Skaha Ballroom

This session will include a brief overview of the mandate and work completed to date by the office of the Auditor General for Local Government followed by a presentation on the summary findings from the recently completed audit on the topic 'Emergency Management in Local Government' for the Town of Sidney. The audit looks at local government's plans, processes and activities related to the four phase cycle of emergency management as well as business continuity management. Nelson Chan, the chief financial officer for the Capital Regional District will conclude the session by briefly sharing their audit experience. Presenters: Gordon Ruth, Marina Chen, Nelson Chan

13:45 Advanced Development Finance: Developer Cost Recovery Mechanisms *Pennask Room*This session will go well beyond a "Development Finance 101" level of detail, to explore some of the difficult questions that arise in the creation and administration of developer cost recovery mechanisms under Part 14 of the Local Government Act. Topics will include DCC setoffs and credits; DCC front-ender agreements; excess and extended service requirements and latecomer charges; and development works agreements. Major development projects can be significant opportunities to advance local government infrastructure plans without exhausting local government financial resources or exposing the local government to real estate market vulnerability. These opportunities are sometimes missed due to developer and staff unfamiliarity with cost-recovery mechanisms. The objective of this session is to enable finance officials to initiate and lead development discussions, rather than listening to poorly-informed developer proposals and having to say "no". Presenter: Bill Buholzer

13:45 Environmental Liability Planning & Resilience Shuswap Room

The session will cover the differences between the civil liability and regulatory liability with regards to insurance planning and environmental liability budgeting. Key areas where insurance may actually be a valuable spend and when self-insurance/Tax SPV may be of greater use versus the Provincial disaster relief funds. The differences between non-environmental policies pretending to capture the exposures versus true dedicated environmental liability and the tail exposure will be clearly highlighted as will the integration of multi-year infrastructure management and spending to avoid and manage environmental exposures (drainage systems, sewage systems, land-fills, parking lots, etc.). Leadership driving change, especially when dealing with infrastructure budgeting as a means to manage environmental losses and control environmental exposures arising from aging infrastructure. Presenter: Justin Perry, Jerry Chien

13:45 It's Not Just Math: How Water Rates Drive Policy & Shape Your Community Skeena Room Setting water rates is challenging, but it's not just a mathematical problem. When we increase rates or make changes to the rate structure itself, we also implicitly move a cluster of different policy drivers. These decisions shape how our water systems perform, and ultimately what our communities will be like in the future. Key drivers include:

- revenue sufficiency: do we have enough to run the system now and forever?
- revenue stability: is the revenue stream consistent from year to year?
- simplicity: do residents understand how they are being charged? Or why?
- affordability: are rates as low as they can be?
- sustainability: are we encouraging people to use water efficiently?
- equity: are customers and customer classes being charged fairly?

This presentation will share ideas about how to use water rates to drive your community's policy goals. Along the way, it will provide some really useful tips and links to resources that will make the whole rate setting process less work and less of a hassle.

15:15 HR Forum: Sick Leave, Disability & Hidden Costs of Doing Nothing Differently *Skeena Room* This session will include a discussions of: defining sick leave and disability; the information gap – capturing lost time costs; direct costs; indirect costs; presenteeism; calculating your lost time costs; managing and amending accumulating sick leave bank plans; actionable change (measures, program, prevention); followed by a Q&A. 15:15 Collector' Forum *Pennask Room*

The Collectors' Forum is an informal session that will provide an opportunity to discuss issues of common concern related to property taxation, including home owner grants, tax deferments, scholl tax and assessments. There will be subject matter experts in attendance to participate in the panel and round table discussions. This session will open with introductions followed by presentations from guest speaker panelists regarding the 2018 Provincial Budget as it relates to local government property taxation and an update on assessments. The session will also include an open mic round table discussion and Q&A facilitated by the moderator. Presenters: Doug Stein, Angie Schumacher, Steven Emery, Kally Khaira, Steven Harrison, Samantha Taylor.

15:15 Leveraging Business Intelligence Tools Shuswap Room

Putting the "smart" in smart cities, business intelligence tools have a big role to play as cities are transformed by technology. Business intelligence technology encompasses a wide variety of techniques and tools for analyzing data and transforming it into meaningful and useful information. For the local government finance officer, business intelligence has the potential to greatly improve the strategic and operational efficiency and effectiveness around financial reporting, performance management and benchmarking. This session will explore three distinct business intelligence tools. Yoginder Balla, CFO from Village of Ashcroft, will present on Microsoft's BI Tools; Michael Brydon, elected representative on the board of the Regional District of Okanagan Similkameen, will present on Benchcube Analytics; and Chad Stewart, Research Analyst from CivicInfo, will present on CivicStats.

16:00 HR Forum: Group Benfits, Who Should be at Risk? Skeena Room

The cost of group benefits, defined as life insurance, disability, health and dental for this discussion, has been increasing for decades at rates well in excess of inflation. While there has been changes to plan designs over the years, the fundamental approach to coverage has not evolved at the pace of treatment options. At the same time many of the treatments leading to these cost increases are curing previously incurable disease and enhancing quality of life for plan members. The session will provide a brief overview of the evolution of risk in group benefits but quickly move to address the two fundamental questions of risk sharing and stakeholder integration culminating in a discussion of alternatives for stakeholders to consider in managing the delivery approach of benefits to fit with their philosophical beliefs. 8:45 A New Framework for Financial Sustainability Skaha Ballroom

For the last year and a half, GFOA has been working on a new framework for financial sustainability. The new framework includes many of the best practices you are familiar with from GFOA such as financial policies and long-term planning. It also includes new ideas based on exhaustive research into how public sector organizations can maintain financial health for the long run. Presenter: Shayne Kavanagh

10:00 Infrastructure Resilience Skaha Ballroom

Local governments face a growing range of adversities and challenges. Forest fires, floods, earthquakes – certainly these are shocks we need to get ready for. But resilience does not only mean emergency preparedness. Many cities across BC have seen economic boom and bust. What about long term stresses like aging populations, aging infrastructure, and the wage gap? How will you be sustainable? Let's take a holistic view to understanding the inter-dependencies of systems, the biggest risks, and the principles and characteristics of resilient cities, so that local governments can focus their efforts when designing initiatives and projects. This presentation will explore the following themes: Urban resilience strategies; Embedding a resilience culture; Business Intelligence / Predictive analytics; Long term risk management; and The rise of the CRO (Chief Resilience Officer). 11:00 Beyond the Baseline: Finance, Risk and the State of Asset Management Skaha Ballroom

Given that it is not a matter of if a catastrophic earthquake event will strike BC, but a matter of when, managing the associated risks is critical to local government's ability to not only respond to, but to recover from such an event. This panel will explore the current state of asset management in BC in terms of the risks associated with natural disasters—specifically, a catastrophic earthquake. Wally Wells from Asset Management BC will moderate this session. Wally will be joined by Glen Brown from UBCM, who will provide key findings from the 2016 UBCM Asset Management Assessment Baseline Survey, Andy Wardell from the District of North Vancouver, who will share what the District has been working on in terms of evaluating the financial impacts associated with a catastrophic earthquake event, and Maryam Sherkat from the Municipal Insurance Association of BC, who will discuss the role of risk pools in mitigating some of the expected financial risks of what would likely be the largest natural disaster to hit BC. Successful organizations are focused on results, and they articulate their desired objectives and outcomes in such a way as to ensure that the whole organization is pulling in the same direction. Is your organization pulling at full strength? The session will demonstrate how the strategic plan is used to create the right measures and KPIs at multiple stages of service or program delivery. 15:00 Cybercrime: Staying Ahead of the Curve Schuswap Room

Around the world, organizations are racing to implement new technologies, using data to innovate and provide value in an increasingly interconnected world. This hyper-connectivity increases cyber risks, and therefore organizations must be vigilant about not only their own security, but that of third party service providers, clients and even governmental authorities. Cybercrime prevention is a responsibility that is shared across all departments of an organization. Proper controls and safeguards must be taken seriously. The costs incurred by victims of cybercrime are increasing and wide ranging. Cybercrime is on the rise! 
